Re: Trail Overlay Project

After the recent rains, the project foreman went out to the trail and noticed with the water sitting on it more material would be necessary to bring up the low spots. They are requesting an additional 150 tons at \$144.15 per ton. The total request is \$21,622.50. The City will only be billed for material needed, so it may be under the estimate.

The project comes in under the project's budget, even with the additional material.
