**Considered variance request** for reduced front yard setback for building in H - C district west of the service road on west side of Hwy 12 between the Kountry Inn Motel and Mobridge Gas.

Ordinance requires a 30 foot front yard setback

The variance requesting the set back be reduced to 10 feet.

The zoning board recognized the irregularity of front yard set backs of other building in the immediate area,

Other neighboring business require a front yard for parking while the proposed storage building will not require a parking area.

It was noted that there are no east to west streets in this H-C district, therefore; there wouldn't be any intersection view obstruction to consider.

The reduced front yard setback would not obstruct view of service road traffic.

There was no opposition to the variance at the advertised public hearing.

The variance was approved 3 yes 0 no

Considered the variance request for increased height of front yard fence.

Variance is asking for front yard fence height be increased from 4 foot to 6 foot. Ordinance limits height of front yard fence to 4 feet

Variance was submitted by Sam Merkel for fence at his home located at  $420~8^{\rm th}$  street east.

The board reviewed the request and found the variance was justified on the bases:

That the additional height would not be detrimental to the neighborhood.

Or be an obstruction to any neighborhood residents view Or obstruct the view of traffic from the alley or on 8<sup>th</sup> street.

There was no opposition to the variance at the advertised public hearing.

The variance was approved 3 yes 0 no

The variance is requesting the rear yard set back be reduced from 6. To 4. to feet. And the regulation limiting rear yard coverage be waved due to the large side yard which is considered as rear yard on this property & the height of the 2 story house be considered when addressing the increased height of the proposed garage.

The zoning board did recognize that the proposed garage would be compatible with existing improvements in the neighborhood and the reduced rear yard reduced set back would not create a hardship for others adjacent to, or those that use the alley including the city and public services. The board also felt that increasing the height of the proposed building from 18' To 20 feet would conform with other structures in the neighborhood.

There was no opposition to the variance from the public at the advertised public hearing or from anyone via the mail, telephone or in person.

The variances were approved 5 yes 0 no

The board agreed 5 to 0 to extend the permit issued to Kingdom Hall on August 17<sup>th</sup> 2018 be extended one month thru September 2019

The board had limited discussion of a structure in the Light Industrial District. The discussion was for information only, No conclusions were made or asked for.
